

RULES FOR ELECTION OF DELEGATES: Each of the Republican Party of Florida's twenty-five (25) congressional district caucuses will elect three (3) delegates and three (3) alternates to the National Convention. Republican congressional district caucus membership includes the County Republican Executive Committee Chairman and Republican State Committeeman and Committeewoman for each county with territory located within the geographical boundaries of the respective congressional districts. Only congressional district caucus members are entitled to vote for delegates and alternates, and the elections will be conducted by the elected chairman of each respective congressional district caucus. The Executive Board of the Republican Party of Florida will elect thirty-six (36) at-large delegates and thirty-six (36) alternates. The election of at-large delegates and alternates will be conducted by the Chairman of the Republican Party of Florida. In order to be eligible to run for the position of delegate or alternate, a candidate must be a registered Republican in Florida as of March 3, 2008. Candidates for congressional district delegate or alternate must reside in and be elected from the candidate's congressional district as of March 3, 2008. All candidates for delegate or alternate must submit a signed and notarized delegate qualifying oath and application to the Chairman of the Republican Party of Florida 420 East Jefferson Street, Tallahassee, FL 32301, between noon March 3, 2008, and noon March 7, 2008. Delegate qualifying oath and application forms may be obtained on the web at www.rpof.org. No fees or assessments may be charged to any candidate for delegate or alternate. No candidate may be discriminated against for reasons of sex, race, religion, color, age, national origin or physical disability. Delegates shall be equally divided according to gender as nearly as possible.
